

# PRODUCT DATA SHEET #300 Plastic Roof Cement

### **USES**

AIM #300 Plastic Roof Cement is a trowel-applied Plastic Cement used to install, repair or rebuild roof flashings at parapet walls, gravel stops, stacks, vents, monitors and similar applications. AIM #300 Plastic Roof Cement may be used with fiberglass, polyester fabrics or roll roofing for permanent repairs.

#### **DESCRIPTION**

AIM #300 Plastic Roof Cement is manufactured from Type I Roofing Asphalt, petroleum solvents and non-asbestos reinforcing fibers. It applies fast and smooth and breaks cleanly off the trowel without stringing.

## **APPLICATION**

The surface to be repaired must be clean, dry and free of debris. Apply AIM #300 Plastic Roof Cement evenly with a pointed roofer's trowel or gloved hand. AIM #300 Plastic Roof Cement should be applied 1/8 to 1/4 of an inch thick and may be reinforced with glass membrane or polyester fabric to strengthen the repair. When making a permanent repair to a blister, open up the area and allow it to dry thoroughly. Clean up with mineral spirits or waterless hand cleaner. Use care when handling solvents.
