DESCRIPTION

AIM #703 Silicone Sealant is a flashing grade, silicone roof patch designed to be installed in a single application, without reinforcement, on a variety of substrates. Provides superior adhesion and flexibility. AIM #703 is weather resistant and withstands extreme elongation. AIM #703 is designed to be highly reflective and UV stable with direct exposure to sunlight.

USES

Ideal for use on new or existing roofs for roof maintenance. AIM #703 provides excellent adhesion to concrete, masonry, polyurethane foam, EPDM, aged PVC, aged acrylic coatings, granular cap sheet, wood, metals, Kynar® and most other common building materials. May be applied to wet and underwater surfaces.

Note: Contact AIM prior to application to TPO roofs.

SURFACE PREPARATION

Surface to be sealed must be clean but may be damp. Remove dust, dirt, oil, loose granules, mildew, and any other foreign contaminants. Rusted metal should be cleaned with a wire brush. Acceptance of the substrate is the sole decision of the owner or appointed representative.

APPLICATION

For exterior use only. Apply on warm, sunny day preferably in the morning to provide maximum cure time.

AIM #703 can be applied in the Three Course Installation Method using a paintbrush, or trowel. Apply first coat at a thickness of 1/8-1/4 inch (3.2mm-6.4mm). While first coat is still wet, place polyester fabric and brush to remove air pockets and wrinkles. Second layer should be applied immediately at a thickness of 1/8-1/4 inch (3.2mm-6.4mm). If needed, trowel AIM #703 over cracks in concrete, masonry, and wood. Additional applications may be necessary, as elastic cement shrinks through drying.

Maximum recommended joint width and depth for mastic applications is 1 inch wide and 5/8 inch deep. Use backer rod in deep joint sealant applications.

Not recommended for surfaces to be painted.

Clean wet coating with soap and water. Dry coating may be removed with mineral spirits. Use care when handling solvents.
