

PRODUCT DATA SHEET #730 Premium White Elastomeric Roof Coating

DESCRIPTION

AIM #730 Premium White Elastomeric Roof Coating is a white, acrylic based, elastomeric reflective coating for waterproofing and prolonging roof life. This flexible and durable coating adheres to roofing substrates, such as asphalt, single-ply, built-up, modified bitumen roofs, as well as metal roofs and tanks.

USES

AIM #730 Premium White Elastomeric Roof Coating withstands elongation and significantly reduces roof temperature. AIM #730 is listed by CRRC and is CA Title 24 compliant. Read and follow directions carefully. Refer to Safety Data Sheet for proper handling.

SURFACE PREPARATION

Surfaces must be cleaned, dried, and free of moisture on and beneath the surface. Remove dust, dirt, oil, loose granules, and any other foreign contaminants. Surfaces must be power washed cleaned with a roof detergent (such as AIM #110) then rinsed thoroughly. The surface may be damp but must be free of standing water. Rusted metal should be cleaned with a wire brush. It is recommended to repair all holes, leaks, and cracks with AIM #740 White Acrylic Mastic and polyester fabric in the Three Course Installation Method. This product displays very good resistance to intermittent ponding water. However, when applied to areas that retain water permanently or near-permanently, service life will be severely diminished and adhesion failure can be expected. Acceptance of the substrate is the sole decision of the owner or appointed representative.

APPLICATION

For exterior use only. Apply on warm, sunny day preferably in the morning to provide maximum cure time. AIM #730 must be applied to a dry surface. Prior to application water must be swept out of all puddles, waterways, and birdbaths. Temperature should be 55°F (12.8°C) and rising. Stir thoroughly before application to achieve a uniform consistency. Apply with a heavy-duty paint roller or professional spray equipment. Apply first coat at a rate of 1.5 gallons per square (5.5 liters per 9.3 square meters). Allow a minimum of 4 hours to dry. Apply second coat in cross hatch fashion at a rate of 1.5 gallons per square (5.5 liters per 9.3 square meters). Allow at least four hours between coats and 24–48 hours for full cure, dependent upon weather conditions. Relative humidity will directly affect drying/curing time.

CLEANUP

Clean wet coating with soap and water. Dry coating may be removed with VM&P Naphtha or Mineral Spirits. Use care when handling solvents.


