The Monograph states that temperature plays an important role in determining the degree of exposure and also the carcinogenic potential of bitumen emissions. This same Monograph states that Asphalt is non volatile at ambient temperature. There is no data presented in the Monograph to demonstrate that Asphalt at ambient temperature is considered a carcinogen. Since the normal use of this product is at ambient temperature, the Asphalt used in this product is not listed as a carcinogen. No other

national or international agency has defined Asphalt as a carcinogen.
