DESCRIPTION

AIM #115 Acrylic Bonding Primer is an acrylic water-based elastomeric super primer. This primer base is a modified acrylic latex polymer for self-crosslinking and offers outstanding flash rust resistance. This primer reduces absorbency of subsequent coatings and enhances adhesion bond quality. This quick-drying clear super primer has excellent long-term durability, and provides outstanding adhesion to tough substrates and surfaces.

USES

AIM #115 Acrylic Bonding Primer's creative formulation makes it a very versatile water-based primer. This primer has excellent adhesion over most single ply membranes, smooth and or granulated APP, TPO, SBS, metal, and carbon steel, Not recommended over BUR systems or mopping asphalt. Can be applied over asphalt emulsion surfaces. AIM #115 Acrylic Bonding Primer aids in the adhesion of acrylic coatings.

SURFACE PREPARATION

Surfaces must be cleaned, dried, and free of moisture on and beneath the surface. Remove dust, dirt, oil, loose granules, and any other foreign contaminants. Surfaces with mildew growth must be cleaned with AIM #110 Detergent Primer or a bleach solution; then rinsed thoroughly. Rusted metal should be cleaned with a wire brush. Pressure washing surface is recommended for best results. Repair all holes, leaks, and cracks with AIM #740 White Acrylic Mastic and polyester fabric in the Three Course Installation Method. Acceptance of the substrate is the sole decision of the owner or appointed representative

APPLICATION

For exterior use only. Apply on warm, sunny day preferably in the morning to provide maximum cure time. AIM #115 must be applied to a dry surface. Prior to application water must be swept out of all puddles, waterways, and birdbaths. Temperature should be 55°F and rising. Stir thoroughly before application to achieve a uniform consistency.

Apply with a professional spray equipment. Apply one coat at a rate of 0.5 gallons per square. Allow a minimum of 4 hours to dry and 24–48 hours for full cure, dependent upon weather conditions.

Clean wet coating with soap and water. Dry coating may be removed with mineral spirits. Use care when handling solvents.
